Solidarity for Haiti Now!

Local 8751 is working with a broad array of Haitian community organizations, elected officials, community activists, clergy, unionists, women's organizations, and others to build a united response to come to the aid of our sisters and brothers suffering in Haiti. We began the effort with our emergency response meeting on Wednesday, January 13<sup>th</sup> hosted by the Local and International Union, Fanmi Lavalas; the Organization of Former Members of Mahanaim, Inc.; AFAB-KAFANM (Association of Haitian Women of Boston); Boston City Councilors Chuck Turner, Charles Yancey, Felix G. Arroyo, & Ayanna Pressley; Bishop Felipe Teixiera; International Action Center; FIST; and others.

The meeting was chaired by Frantz Mendes, President of USW Local 8751. Boston City Councilors expressed solidarity with the people of Haiti and those in the room with family and relatives in Haiti, and offered the resources of their offices to facilitate assistance in any way possible. USW District 4 Staff Rep. Joe Carlson read a letter from USW International President Leo Gerard expressing solidarity with the people of Haiti. The union has donated \$20,000 toward relief efforts, and those in the meeting pledged to seek more. A coordinator for Fanmi Lavalas Boston described the devastating conditions on the ground in Haiti and indicated Fanmi Lavalas will continue to work tirelessly in support of the Haitian people. Jonathan Regis of FIST discussed efforts to establish communications and coordination in the search for missing persons. The information he collected at the meeting has been forwarded to appropriate authorities including the Haitian Consulate and the State Department. More information concerning donations, materials, and medical supply drives will be forthcoming. Emergency response organizing is taking place through Boston Public Schools; area colleges and universities; and many local churches.
